Seminars will also include the **sharing of experiences**, the viewing of **mini-videos** and the review of **famous extradition cases**.

- review of recent developments in extradition case-law (ECJ, ECHR and selected domestic Supreme Courts);
- a set of skills for extradition cases;
- a set of “lines of argument” for extradition cases;

- a network of colleagues expert in extradition-related matters.
